Maratha grp booked for forced entry

MUMBAI

The Bandra police have booked 15 unidentified persons, who were travelling in four vehicles towards Azad Maidan to participate in the Maratha protest on Monday evening, for alleged unlawful assembly, wrongful restraint, disobedience of lawful orders promulgated by a public servant, and obstructing a public servant in the discharge of official duties. This action followed their misconduct towards police on bandobast duty at the Bandra-Worli Sea Link (BWSL) toll plaza.

Police inspector Sudarshan Gaikwad, in his complaint, said they refused to follow the diversion orders, disrupted the area, and forcefully entered the BWSL to proceed to the protest site. On-duty personnel attempted to stop them, but the protesters began filming the police while pushing through barricades. The convoy included two pickup vans and two SUVs, all of which have been identified by their registration numbers. A Bandra police officer said no arrests have been made but they are tracking the vehicles through CCTVs.

Search ends: Missing mall dog Laila found in Borivali

Allegedly abducted in May; rescuer Shiraj Ahmad to pursue case legally

MUMBAI

A viral social media post, a group of dedicated animal lovers and a six-hour dramatic search operation in the wee hours led to the miraculous discovery of Laila, Mumbai's beloved mall dog that was abducted more than three months ago.

On July 25, the FPJ had reported about the missing Indie dog Laila, who was widely popular on social media and admired by the visitors of the mall. The community dog was allegedly abducted on May 21. The BKC police registered an FIR against Chetan Salvi, Suraj Chauhan and Parvez, who allegedly took Laila in a car. The complainant, Shiraj Ahmad, an animal activist and founder of Humanity World Foundation, was informed by a fellow animal lover that Laila was last seen in Sanpada.

Ahmad and his friends had been looking for Laila on the streets of Sanpada every night for the last three months. The group did it all – from putting up missing posters, distribu-

ting pamphlets, announcing Rs25,000 reward as well as wrapping Ahmad's car with posters informing people about Laila. During a post-midnight hunt on Thursday, Ahmad received a forwarded social media post by Shilpa Lewis, who claimed that a dog had lost her way and was found in Borivali's IC Colony. The pictures attached made it clear that it was indeed Laila, who was seen sitting on a scooter with an unknown man. Ahmad and his friends left for Borivali and started looking for Laila in the IC Colony spread across 25 hectares. As it was difficult to find

her in the vast residential neighbourhood at 3am, the group searched for the scooter through its distinct features. Once the scooter was located, its owner too joined the search operation.

Before dawn could set, the group of 10 divided into different teams with some on foot, some on scooters and some on rickshaw, all looking for Laila. Finally, at around 9.30am, one of the teams successfully located her hiding under a car parked in one of the societies. On inquiry, it was learnt that the society had allowed Laila to live on its premises but one day she ran from the society

due to loud noise during Ganpati Visarjan. The photo was clicked by Lewis, who posted it on social media.

Ahmad told the FPJ, "For the last three months, my schedule included my job and NGO during the day and to look for Laila during the night. We looked for her till as far as Panvel. I believe that when our intention is pure, God blesses us with his blessings. It is the result of our honesty that we were able to find her."

Even after being forcefully relocated, Laila survived all odds but suffered a few injuries and maggot infestation. Following treatment, she was taken back, not to the mall but to Ahmad's residence. The animal lover alleged that the mall offered to welcome Laila back and look after her but he refused owing to lack of trust.

"They might take her back for now but throw her out after a month. The mall does not deserve Laila. I will ensure that she lives safely with me at a home where she is valued," Ahmad said, adding that he will continue to pursue the matter legally and ensure that justice is served to Laila.

GRP cracks 7-yr train theft racket, arrests 2

MUMBAI

The Government Railway Police (GRP) has busted a gang of thieves from Uttar Pradesh who stole valuables from the luggage of sleeping passengers on long-distance trains. Two persons have been arrested, while a search is underway for four others.

With these arrests, 16 crimes have been solved, and stolen property worth Rs22 lakh, including 315,460gm gold and Rs72,000 in cash has been recovered. The accused, Waqar Khan, 39, a resident of Ghazipur, and Jugal Vishwakarma, 41, a resident of Kanpur, were arrested in Kalyan.

Commissioner of Mumbai railway police, Rakesh Kalasagar said, "The gang had been active for the last seven to eight years on the Central

Railway line, and this is the first time the railway police have arrested them."

Khan is believed to be the kingpin of the gang, who roped in different people for different crimes. Efforts are on to nab the remaining four members.

The most recent theft occurred on May 23, on a Coimbatore-bound train, where Rs3.5 lakh was looted from a sleeping passenger. All the crimes were committed under the jurisdiction of Central Railway, covering the Kalyan, Thane, Karjat, and Dombivli GRP police stations.

Car crashes en route to Lalbaugcha Raja, 1 dead

Palghar: A car carrying seven devotees from Vadodara to Lalbaugcha Raja crashed into a stationary truck near Naigaon on the Mumbai-Ahmedabad Highway Wednesday evening, killing one and injuring six. The deceased was identified as Ketulbhai Patel, 32. The police said the truck driver, Suryabali Tiwari, had parked without switching on the hazard lights, indicators, or reflectors, making it difficult for the approaching car driver to notice the truck in the dark. A case of negligence has been registered. Further investigation is underway. In another incident, a 32-year-old biker was killed after being thrown off a bridge following a collision involving two cars in Bhiwandi on Wednesday evening.

NCCF onion vans pan out across city, sale at ₹24/kg

Mumbai: As part of an initiative of the Union government, the National Cooperative Consumers' Federation of India (NCCF) has started selling onions through mobile vans in Mumbai at subsidised rates of Rs24 per kilo in an effort to keep retail inflation under control.

These vans will move across wards in Mumbai to sell onions at rates lower than prevailing market prices, an NCCF official said. "We expect daily sales of about 10 tonnes. The intervention is

linked to the government's effort to keep retail inflation in check. The scheme was introduced last year when

onion prices had surged to Rs100 per kg, prompting the government to tell them at Rs35 per kg," the official said.

The Centre, on Thursday, kick-started the subsidised sale in Delhi, Mumbai and Ahmedabad. After flagging off mobile vans in the national capital, Union Food Minister Pralhad Joshi said about 25 tonnes of onions from the buffer stock will be sold in these cities through cooperative agencies – National Agricultural Cooperative Marketing Federation of India (Nafed), National Cooperative Consumers' Federation of India (NCCF) and Kendriya Bhandar. Joshi

said the subsidised sales would take place in areas where retail prices are ruling above Rs30 per kg.

Consumer Affairs Secretary Nidhi Khare said selling onions at this stage before the festival season would help recover procurement costs and ensure availability at affordable rates for consumers.

Onions grown during the rabi season in Maharashtra, Gujarat and Madhya Pradesh form the bulk of the buffer stock. —PTI
